PARTICIPANT

The number of participants is limited to 230 this year. Anyone who owns an officially registered and insured historic off-road sports motorcycle (built up to and including 1990) that complies with the requirements/regulations of the StVZO at the time of the event is allowed to take part. Every participant must have a driver's license that corresponds to the category of the vehicle (must be presented when registering).

There is a general obligation to wear a helmet in accordance with the currently applicable ECE-05 standard. Wearing suitable protective clothing is also required. If these conditions are not met on the day of the event, you will not be allowed to start. The tires must have a "DOT" number or "E" marking. Tires without this marking may only be used if they are entered in the vehicle documents.

GENERAL INFORMATION

- 1-day event with award ceremony Saturday afternoon -Route length approx. 50 kilometers (terrain/field paths/road)
- Start test (20 meters within one minute under one's own power)
- Enduro – Test (approx. 2km of selective terrain including ascents and descents)

- 2 ZK's (time controls) ->at the paddock (incl. fueling zone) and before the cross test in Crawinkel -Acceleration test -T ri al- T est

3 laps of approx. 50km / 2 laps for the U5 + women class

ENTRY/ENTRY FEE

Entries are only possible via the online entry form, which can be found on the homepage of our website. Online entries are carried out by TRIGA timekeeping.

ENTRY START: 03.08.2024 / **ENTRY DEADLINE: 23.08.2024**

The entry form is not limited to a specific number of participants. After the entry deadline, 230 drivers will be selected.

The entry fee, which is to be paid to the account listed below (85€ per starter), should be received by us no later than 10 days after the entry confirmation.

All riders receive a start number (front) upon registration, so there are no fixed start numbers !
